GTCF is seeking an experienced philanthropic advisor with extensive knowledge of and experience with charitable giving tools and strategies to work collaboratively with donors, professional advisors and the GTCF Team to inspire catalytic philanthropy in Pierce County.

ESSENTIAL FUNCTIONS

Fund Development & Stewardship

- Develop and implement philanthropic tools and strategies to engage individuals, families, businesses, governmental agencies, nonprofits, and Professional Advisors to drive assets to and through GTCF.
- Manage a dynamic portfolio of active and prospective fund advisors to ensure proactive engagement and stewardship of relationships.
- Develop a cadence of reporting that ensures monitoring of cultivation strategies, actions, and engagement activities to ensure progression of opportunity stages.
- Leverage existing priority donor relationships to build the next generation of fund advisors, prioritizing prospect potential and capacity for new giving, renewed or elevated giving, gift planning, and activation of complex assets.
- Collaborate with professional advisors and draw on a working knowledge of current giving strategies involving cash, securities, qualified charitable distributions, charitable gift annuities, donor-advised funds, endowments, beneficiary designations, wills, and trusts.

Gift Planning & Complex Assets

- Inspire referrals and follow-up on inquiries from prospects, donor representatives, other nonprofits, and professional advisors regarding gift planning and complex assets.
- Develop and provide financial illustrations for prospective donors for charitable gift annuities and charitable remainder trusts highlighting tax and cash-flow opportunities.
- Staff the GTCF Complex Gift Committee and facilitate complex gift acceptance.
- Maintain talent cloud of support for complex gifts.

Professional Advisor Liaison

Professional Advisors include: attorneys, accountants, wealth advisors, trust officers, brokers, life insurance professionals, accountants and planned giving professionals.

- Sustain a robust Chartered Advisor in Philanthropy (CAP) alumni community.
- Co-facilitate and recruit CAP Study Cohort.
- Cultivate and strengthen relationships to increase quantity and quality of referrals.
- Serve as the key relationship manager with Professional Advisors (PAs), educating them about GTCF's philanthropic tools and services and inspiring their client's philanthropic impact.
- Prepare and hold meetings with Professional Advisors to educate them about GTCF in large events and small group sessions, as well as one-on-one meetings.

Cross-Team Collaboration

- Work in partnership as a close and valued colleague with the rest of the GTCF team, fostering
 and supporting cross-team collaboration, serving as a knowledge resource and thought partner
 to other GTCF team members, enabling them to do their best work.
- Partner with community impact, communications, and finance teams to inspire, inform, and educate constituents on charitable giving.

COMPENSATION

GTCF offers sustainable compensation packages that are competitive with similar philanthropic sector positions requiring comparative talent, experience, and skills so that GTCF retains a thriving, productive staff team capable of advancing our strategic framework.

The salary range for this position is \$105,000 to \$135,000 annually.

GTCF has a 36-hour work week with standard business hours Monday through Thursday and Fridays closing at 12 pm. This is a hybrid work environment, with collaborative meetings in person as well as a home office structure.

Other benefits include 3 weeks' vacation in the first year, 16 fixed holidays including the full week of Thanksgiving, 2 floating holidays, 2 personal days, 8 sick leave, health, vision, and dental insurance, short- and long-term disability insurance, 401(K) retirement plan, life insurance, free parking, free gym access and a monthly home technology stipend.
