Dear Fundholder of Greater Tacoma Community Foundation:

We are pleased to share your Quarterly Fund Statement for the period **July 1 through September 30, 2017**.

The fund that you established with GTCF is invested in our Socially Responsible (SRI) Pool which was established in February 2016. The SRI Pool integrates Socially Responsible Investing factors into the security selection process for a portion of our endowed assets.

Global stock markets continued with strong performance during the third quarter. As the markets advanced, so did GTCF's SRI Pool, posting a +2.9% return for the quarter compared to the target weighted benchmark of +2.9%.

This has been a busy and productive year for Greater Tacoma Community Foundation. Thanks to the support of dedicated philanthropists and collaboration from community leaders, GTCF has been able to inspire positive change in many different sectors.

In July, GTCF and Tacoma Public Schools were awarded an implementation grant from The Wallace Foundation to develop a pilot program in collaboration with after-school programs, expanding social and emotional learning. Tacoma was one of only six cities in the nation to receive the funding. The other five cities are Boston, Denver, Palm Beach County, and Tulsa. Tacoma's grant was achieved through a collaborative planning process including GTCF, Tacoma Public Schools, University of Washington-Tacoma, Foundation for Tacoma Students, and School's Out Washington.

In July and August, GTCF led two workshops for the Fund for Women and Girls' Women's Economic Opportunity Initiative. More than one-hundred leaders from nonprofits, businesses, academic institutions, government, and civic organizations gathered in July and August to learn about the economic status of female heads of household in Pierce County who are living on the brink of financial security. At each workshop, participants heard real-life stories, research from a variety of sources, and expert speakers before engaging in knowledge-exchange, conversation, and brainstorming.

In September, GTCF celebrated ten awardees for the 10th Foundation of Art Award. This year's artists work in a wide range of artistic mediums, from painting and sculpture, to fabric and letterpress. Each artist received \$1,000 for showing work at a Spaceworks Gallery exhibit. Hundreds of community members attended a reception during the Third Thursday Art Walk on September 21 that featured live music, dancers, and even fire jugglers performing up and down Broadway.

All of the achievements for the community are made possible through your dedication to a thriving community. Your partnership is vital to GTCF's success in supporting Pierce County.
